#### **Foundation:**

**New Business: Approval of items voted on at September SEAC and approval of procedural manual changes from SEAC**

- \$1,200 Aaron Duell— Discussion took place on what exactly he does. Could we have a student do it? We have to have him.
- ✚ Motion: Raimie moves to have an honorarium of 1200 dollars for Aaron Duell and 500 for Erin Petersilie. Seconded. Adopted

- ✚ Motion: Megan moved to hire an auditor for the past fiscal year. Seconded. Adopted

**Procedural Manual Changes:**

**Problem with current policy:** There is no statement found in the procedural manual stating that all students must be accompanied by an advisor/adult at every event

**Suggestion for change:** Add an item #12 which states: All students must be accompanied by an advisor/adult that is the age of 21 or over that will be responsible for them at every event sponsored by KS FCCLA

- ❖ Motion: Bree Dowd moved to accept procedural change #1, with the added change of age  
Seconded: Kacey Voted: Adopted

**Problem with current policy:** Nothing is state in the procedural manual.

**Suggestion for change:** All district officers must be a member of an active chapter in the assigned FCCLA district. Active is interpreted as having a currently employed FACS teacher be the FCCLA advisor and national, state and district dues have been paid.

- ❖ Motion: Raimie moved to accept procedural change #2  
Seconded: Bree Vote: Passed

**Problem with current policy:** Policy states the state advisor shall register all KS participants, however due to varying arrival of delegates and increased registration times; it seems a better directive for local chapters to register themselves once at the conference.

**Suggested Policy Now:** "E. It will be the responsibility of the chapter advisor, or assigned sponsor to register online and to pick up individual registration packets at National Leadership Conference.

- ❖ **Motion: Bree moved to accept procedural manual change #3**  
**Seconded: Megan Voted: Passed**

**Problem with Current Policy:** The state advisor has been responsible for overseeing check in at the NLC lodging location. This creates problems with early arrivals and those who cannot arrive at the lodging location during identified check in times.

**Suggested policy:** “D. The state advisor will make NLC sleeping room and duty assignments as well as arrange for the official lodging reservations, chapters will still make payments to state office( Kansas FCCLA) for lodging, however it will be the responsibility of the chapter advisor, or assigned chapter sponsor to actually check in all delegates associated with their school group.

Dalton Noakes gave the State Executive Council report, he discussed with the board what the SEC is doing while getting in preparation for the State Leadership Conference. Kacey Preston did not have a report to give for Alumni and Associates. Bree Dowd gave the District President report followed by Bobbi Anderson giving the Peer Education report. Finally, Dreana McClurg gave the Foundation report.

**Old Business**

We started old business off by reviewing the Strategic Plan for FCCLA. After reviewing, we moved on to the Capitol Leadership report given by Raimie Platt. Raimie gave a presentation over Capitol Leadership, which six of the state officers attended back in October. After the presentation we discussed the idea of lowering the budget for state officers. A motion was made:

- Bree Dowd moved to establish the funds for Capitol Leadership not to exceed \$2,500, Kansas FCCLA will not exceed more than a quad registration per person, in effect for the 2012-2013 State Officers. (Seconded)(Passed)

Finishing up old business was district policies and procedures report. We reviewed what was decided at SEAC in December about the uniform policy.

**New Business**

State Board approves the motion that passed by SEAC, about the new district officers uniforms.

Procedural Manual Changes:

- Motion: Bree moved to accept P.M.C. of Peer Education. (Seconded) (Passed)

- Motion: Mrs. McClurg moved to move forward with the voting of dues increase from two dollars to five dollars at State Leadership Conference 2012. (Seconded) (Passed)
